

Terms and Conditions for the Summer with a V Campaign - December 2021

- 1. This campaign will run from 4 December until 23h59 on 31 December 2021.
- 2. The campaign is open to all South African citizens who are over the age of 18 years old.

DISCOVERY BANK CLIENTS

- 3. To be eligible for the campaign, the participant must be an existing Discovery Bank client with a Discovery Bank Transaction Account, Discovery Bank Credit Card Account or Discovery Bank Suite.
- 4. A short verification process will take place at the Summer with a V locations (listed in paragraph 5 below) by completing the online form to receive a unique redeemable Vitality Travel branded summer item youcher.
 - a. The voucher is electronic and will be received via the Discovery Bank app
 - b. The voucher can only be redeemed once during the Summer with a V campaign period and must be redeemed on-site with the Vitality promoters at one of the official Summer with a V locations.
 - c. Vouchers cannot be redeemed via social media or the app and will not be valid once the campaign period has ended.
