

## Terms and Conditions for the Vitality Active Rewards for Teens x Apple Watch competition

- 1. The promotor of the competition is Discovery Vitality (Pty) Ltd ("Vitality").
- 2. The competition will run from 1 June 2021 to 30 June 2021. The closing date of the competition is midnight 18 July 2021.
- 3. Entrants into the competition are required to reside in South Africa.
- 3.1 The competition is open to Vitality main members who have activated Vitality Active Rewards and have child dependants between the ages of 14 (fourteen) to 18 (eighteen).
- 4. To participate in the competition, main members must give their consent for their teen to participate in Vitality Active Rewards for Teens, the teen must download the Discovery app on their device and create their own profile under <u>Vitality Active Rewards for Teens</u>. The teen needs to successfully achieve at least 1 (one) exercise goal between 1 June 2021 and midnight 18 July 2021.
- 4.1 If both the teen and the main member under the same policy are found to have successfully achieved at least 1 (one) exercise goal in the same week between 1 June 2021 and midnight 18 July 2021, then both parties will stand to win an Apple Watch SE 40mm each.
- 4.2 If both the teen and the main member under the same policy are found to have successfully achieved at least 1 (one) exercise goal in the same week between 1 June 2021 and midnight 18 July 2021, then both parties will receive an extra play on the gameboard at the end of the competition.
- 4.3 If only the teen successfully achieves at least 1 (one) exercise goal between 1 June 2021 and midnight 18 July 2021, then only they will stand to win an Apple Watch SE 40mm prize.
- 5. Members with more than one child within the above specified criteria will receive a counted entry into the competition for each profile activation in Vitality Active Rewards for Teens and successful achievement of at least 1 (one) exercise goal by their nominated children.
- 6. All consent, creation of Discovery profiles in Vitality Active Rewards for Teens and successful achievement of at least 1 (one) exercise goal by the teen and main member must be completed in the same week between 1 June 2021 and midnight 18 July 2021 in order to qualify for either only 1 (one) Apple Watch SE 40mm for the teen only



- OR 2 (two) Apple Watches for both the teen and the main member, and for each party to receive an extra play on the gameboard.
- 7. Upon closing date of the competition the winner/s will be randomly selected based on their engagement with Vitality Active Rewards for Teens and Vitality Active Rewards during the competition period.
- 8. Data pulled for the purposes of the competition will be based on consent given by the main member, completion of a Vitality Active Rewards for Teens profile created by the nominated minor as stated above and successful achievement of at least 1 (one) exercise goal by either only the teen or both the teen and the main member between 1 June 2021 and midnight 18 July 2021. Winner's data will not be shared with any 3<sup>rd</sup> (third) party.
- 9. There will be an extra play given on the gameboard at the end of the competition if both teen and main member have successfully achieved at least 1 (one) exercise goal in the same week within the time frame specified.
- 9.2 There will be one winning Vitality policy, which will either consist of only 1 (one) teen winner of an Apple watch SE 40mm valued at R5 999 (five thousand nine hundred and ninety nine Rand) or 2 (two) winners of 2 (two) Apple watches if both the teen and main member under the same policy successfully achieve at least 1 (one) exercise goal in the same week within the time frame specified.
- 10. The prize winner will be drawn randomly from the checked entries, the main member will be contacted by Friday 25 July 2021 by either telephone, email, or both. Should the winner not respond within 5 (five) days, an alternative winner will be chosen.
- 11. The winner may be required to appear and be identified on the Vitality social media pages at no fee to them. The prize winner can decline the option of appearing or being mentioned on the Vitality social media pages and will not forfeit the prize should they elect to do so.
